

**ORDINANCE NO. 2025-01**

**AN ORDINANCE REPEALING AND RECREATING SECTION 7.04 (1) OF THE MUNICIPAL CODE OF THE CITY OF PRAIRIE DU CHIEN, CRAWFORD COUNTY, WISCONSIN**

The Common Council of the City of Prairie du Chien, Crawford County, Wisconsin, do ordain as follows:

**Section 1:** That Section 7.04 (1) of the Municipal Code of the City of Prairie du Chien, Crawford County, Wisconsin, is hereby repealed and recreated to read as follows:

**7.04 (SPEED LIMITS)**

(1) The Council hereby determines that the statutory speed limits on the following streets or portions thereof are unreasonable, unsafe and imprudent and modifies such speed limits as follows, and that appropriate signage be erected to designate the restricted speed within the described areas:

(a) 15 M.P.H.

1. Wells Street from the intersection of Wells Street and Fremont Street to the East end of Wells Street.
2. Dousman Street from the intersection of Dunn Street to the intersection of Taylor Street when School is in session.
3. North Beaumont Road from Washington Street to Cedar Street when School is in session.
4. South Michigan Street from East Iowa Street to East Dunn Street when School is in session.
5. South Wacouta Avenue from East Dunn Street to East Iowa Street when School is in session.
6. Water Street from Blackhawk Avenue to Villa Louis Road.

(b) 30 M.P.H.

1. East Blackhawk Avenue, from Marquette Road to the east City limits.
2. South Marquette Road, from Blackhawk Avenue to a point 200 feet South Campion Boulevard.
3. North Marquette Road, from Blackhawk Avenue to 200 feet South of East Cedar Street.

(c) 35 M.P.H.

1. South Marquette Road, from a point 200 feet South of Campion Boulevard to the South Corporate limits of the City of Prairie du Chien.
2. Those portions of that certain roadway commonly known as the Highway 18 Bypass from South Marquette Road to its intersection with West Iowa Street is hereby established as a 35 mile per hour speed zone
  3. Frederick Street from Highway 35 to the BNSF railroad crossing.
  4. Cliffwood Drive from Highway 35 to County Road K.
  5. Vineyard Road from start to end of city roadway.

(d) 45 M.P.H. North Marquette Road, from 200 feet South of East Cedar Street to the North corporate boundary of City of Prairie du Chien.

**Section 2:** PENALTIES. Violation of this Ordinance or any part thereof shall be punishable under Section 7.03 of the Municipal Code of the City of Prairie du Chien.

**Section 3:** This Ordinance shall be effective from and after its passage and publication as required by law.
